If this day falls within a public holiday or a legal holiday, the offer preparation period is extended to the next working day. No offers will be accepted after the deadline for submitting offers.

The validity of the offers is set at three (03) months from the date of submission of the offers.

The opening of the envelopes in a public session by the ANF's opening and evaluation committee will take place on the same day as the above-mentioned offer submission date at 14:00, in the presence of the tenderers or their representatives.
